Resolution Appropriating the Sum of Two Hundred Thousand Dollars (\$200,000) from the State

Categorical Grants Fund 231 to the Equipment Maintenance Fund 601/606 and Authorizing the Purchase of a Waterless Sweeper for Use in the Development of the Air Quality PM10 Dust Control Best Management Practices Program within the Municipality of Anchorage (MOA)

The attached Resolution appropriates the sum of \$200,000 from the State Categorical Grants Fund 231 to the Equipment Maintenance Fund 601/606 and authorizes the purchase of a waterless sweeper for use under the air quality PM10 dust control best management practices program within the MOA.

The funding source, previously appropriated, came from the State of Alaska under a Transfer of Responsibility Agreement (TORA Project No. 56549) to develop a best management practices program for control of air quality PM10 particulates. As part of the development of the program, the waterless sweeper will be used to study MOA criteria for PM10 dust control practices. Other MOA sweepers are a wet sweeper which means water or other liquids are used during sweeping operations.

Particulate matter that is less than ten microns in size is defined as PM10. When suspended in the air, this small particulate matter affects humans as it is inhaled, forcing the heart and lungs to work harder to provide oxygen to the body. This can lead to a decreased breathing ability and damage to the heart. The harmful effects are particularly severe in the elderly, children and persons with pre-existing respiratory problems.
