A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF THIRTY SEVEN THOUSAND NINE HUNDRED SIXTY DOLLARS (\$37,960) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES, DIVISION OF STATEWIDE PLANNING HIGHWAY SAFETY OFFICE AND ONE THOUSAND THREE HUNDRED FORTY DOLLARS (\$1,340) AS A CONTRIBUTION FROM THE 2005 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THE SEAT BELT ENFORCEMENT BLITZ PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of THIRTY SEVEN THOUSAND NINE HUNDRED SIXTY DOLLARS (\$37,960) is appropriated as a grant from the State of Alaska, Department of Transportation and Public Facilities, Division of Statewide Planning Highway Safety Office to the State Categorical Grants Fund (231) for Seat Belt Enforcement.

Section 2. That the sum of ONE THOUSAND THREE HUNDRED FORTY DOLLARS (\$1,340) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2005 Anchorage Police Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation and Public Facilities, Division of Statewide Planning Highway Safety Office, of a Seat Belt Enforcement Blitz Grant. (\$39,300)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation and Public Safety, Division of Statewide Planning Highway Safety Office for a grant to support increased seat belt use in the amount of \$37,960.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt use within the Municipality of Anchorage. Through increased awareness and enforcement, the residents of Anchorage will be encouraged to increase seat belt usage to reduce traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected municipal cost is \$1,340, which has been budgeted in the 2005 Anchorage Police Operating Budget. This grant began on May 23, 2005 and will end on September 7, 2005.
