A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF TWO THOUSAND NINE HUNDRED TWENTY FIVE DOLLARS (\$2,925) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES AND ONE HUNDRED THIRTY DOLLARS (\$130) AS A CONTRIBUTION FROM THE 2005 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THE IMPAIRED DRIVING ENFORCEMENT BLITZ PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of TWO THOUSAND NINE HUNDRED TWENTY FIVE DOLLARS (\$2,925), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Impaired Driving Enforcement Blitz Program.

Section 2. That the sum of ONE HUNDRED THIRTY DOLLARS (\$130), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2005 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of an Impaired Driving Enforcement Blitz Grant and local match required. (\$3,055)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a DUI .08 Impaired Driving Enforcement Blitz program. This grant will be used to support enforcement during the period July 1, 2005 thru July 5, 2005.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage have experienced safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$ 130, which has been budgeted in the 2005 Operating Budget. This grant program is being presented for appropriation after the actual performance period due to a delayed notification of award from the State of Alaska, Highway Safety Grants Management Office. This grant began on July 1, 2005 and ended on July 5, 2005.
