THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of SEVENTY EIGHT THOUSAND FOUR HUNDRED EIGHTY FOUR DOLLARS (\$78,484), is appropriated from the State of Alaska, Alaska Court System to the State Categorical Grants Fund (231), Anchorage Police Department, for a Domestic Violence Warrants/Orders program coordination grant.

Section 2. That the sum of TWO THOUSAND EIGHT HUNDRED TWENTY DOLLARS (\$2,820), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2005 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

The Municipality of Anchorage has received a grant from the State of Alaska, Alaska Court System for a Domestic Violence Warrants/Orders Coordination Program. The Alaska Court System has received a federal grant to improve the way domestic violence cases are handled in the Anchorage trial courts. One of the identified problems sought to be addressed by this pass-through grant is the current lack of dedicated law enforcement officers to serve arrest warrants and related orders in cases arising in the Anchorage trial courts.

This grant funding will be used to reimburse overtime for two officers to work a minimum of two nights per week, over the life of the grant program, serving domestic violence related orders and warrants in Anchorage. The documents to be served include; domestic violence protective orders, warrants issued in response to violations of protective orders, warrants issued in response to violations of conditions of release in domestic violence cases, and warrants issued in response to commission of domestic violence crimes. Through increased warrants and orders service, domestic violence victims residing in the Municipality of Anchorage will experience a safer living environment.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$2,820, which has been budgeted in the 2005 Police Operating Budget. This grant began on July 31, 2005 and will end on June 30, 2006.
