The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a DUI .08 Impaired Driving Enforcement Sustaiment program. This grant will be used to support focused enforcement during the period July 1, 2005 thru September 30, 2005.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage have experienced safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$1,240, which has been budgeted in the 2005 Operating Budget. This grant program is being presented for appropriation after the start of the actual performance period due to a delayed notification of award from the State of Alaska, Highway Safety Grants Management Office. This grant began on July 1, 2005 and will end on September 30, 2005.
