In August of 2003 the U.S. Department of Justice, awarded the Municipality of Anchorage a Local Law Enforcement Block Grant in the amount of \$286,363. With the required Municipal match of \$31,818, the total grant program was \$318,181. This grant was used to fund technology enhancements for CJIS/NCIC network encryption and police equipment purchases for enhanced records management technology.

One of the conditions of this grant was that all federal funding be placed in an interest bearing account and the accrued interest must be used for police programs and activities. This grant expires on September 30, 2005, the accrued interest of \$4,738 and the estimated interest of \$662 must be appropriated.
