A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY APPROPRIATING TWO HUNDRED FORTY FIVE THOUSAND TWO DOLLARS (\$245,002) FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT AND EIGHT THOUSAND EIGHT HUNDRED SIXTY DOLLARS (\$8,860) AS A CONTRIBUTION FROM THE ANCHORAGE POLICE SERVICE AREA FUND (151), ANCHORAGE POLICE DEPARTMENT 2005 OPERATING BUDGET, TO THE FEDERAL CATEGORICAL GRANTS FUND (241), ANCHORAGE POLICE DEPARTMENT, FOR THE PURPOSE OF UNDERWRITING PROJECTS TO REDUCE CRIME AND IMPROVE PUBLIC SAFETY.

THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

Section 1. That the sum of TWO HUNDRED FORTY FIVE THOUSAND TWO DOLLARS (\$245,002), is appropriated from the U.S. Department of Justice, Office of Justice Programs, Edward Byrne Memorial Justice Assistance Grant (JAG) Program to the Federal Categorical Grants Fund (241), Anchorage Police Department for the purpose of underwriting projects to reduce crime and improve public safety.

Section 2. That the sum of EIGHT THOUSAND EIGHT HUNDRED SIXTY DOLLARS (\$8,860) is appropriated as a match from the Anchorage Metropolitan Police Service Area Fund (151) to the Federal Categorical Grant Fund (241) for the purpose of underwriting projects to reduce crime and improve public safety.

Section 3. This resolution shall take effect immediately upon passage and approval.

**Subject:** Appropriation from the U.S. Department of Justice, Office of Justice Programs for a Edward Byrne Memorial Justice Assistance Grant (JAG) Award 2005-DJ-BX-0496 (\$253,862)

Edward Byrne Memorial Justice Assistance Grants, authorized by the Crime Identification Technology Act, 1998 (42USC14601), provide local governments with funds to underwrite projects to prevent and control crime based on local needs and conditions. The Municipality of Anchorage has been awarded a grant in the amount of \$245,002 with a required local contribution of \$8,860 for a total program budget of \$253,862. These amounts are requested to be appropriated to the Federal Categorical Grants Fund (241) for use by the Anchorage Police Department. The performance period of this grant is October 1, 2004 to September 30, 2008.

In accordance with program notice requirements, local public officials were presented with the following proposed expenditure areas thirty days prior to grant application submittal:

\$175,000	Incident Command Post Vehicle Interoperable Equipment
\$ 22,500	Digital Imaging System External Agency Record Search
\$ 25,917	Miscellaneous Existing Project Completion Funding
\$ 21,585	Administrative Program Expenditures
<u>\$ 8,860</u>	Intergovernmental Costs
\$253,862	Total Program Grant Expenditures

As required, an advertised public hearing was held on March 15, 2005 at APD Headquarters to provide opportunity for comment by local citizens and community organizations. No public comments were expressed at the hearing.
