Several events, associated with the recent Gregg v. MOA settlement 3AN-98-10263CI and S-10722/10751, the scope of which were initially unquantifiable, have been of significant magnitude to adversely affect the 2005 Police Operating Budget. These events included court ordered payments of attorney fees during the case appeal, attorney fees for settlement process, payment of direct accrued interest to Gregg, and court costs associated with the settlement.

The amount of \$1,400,000 was accrued as an expenditure to the 2004 Police Operating Budget for payment of settlement costs arising from the Gregg v. MOA case. Total department expenditure has reached nearly \$1,939,000 for settlement and other referenced ancillary costs previously unquantifiable and subsequently unbudgeted by the department.

These additional costs have required expenditure of funds budgeted for operational support of planned law enforcement operations. These unbudgeted expenditures have reached nearly \$539,000 and funds are requested as a fund balance appropriation from the Anchorage Metropolitan Police Service Area Fund Balance (151) to the Anchorage Police Department 2005 Operating Budget. The 2006 tax limitation calculation will include a one-time adjustment in the amount of \$539,000 to reimburse the Police Service Area Fund Balance for this settlement cost.
