

A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING NINE HUNDRED SIXTY THOUSAND EIGHT HUNDRED FOURTEEN DOLLARS (\$960,814) FROM THE ALASKA DEPARTMENT OF HEALTH AND SOCIAL SERVICES AS A GRANT TO THE STATE CATEGORICAL GRANTS FUND (231), DEPARTMENT OF HEALTH AND HUMAN SERVICES TO FUND COMMUNITY HEALTH NURSING SERVICES.

THE ANCHORAGE ASSEMBLY RESOLVES:

Appropriating a State of Alaska Department of Health and Social Services Grant

Award for Community Health Nursing Services

The Department of Health and Human Services has received a grant award from the Alaska Department of Health and Social Services in the amount of Nine Hundred Sixty Thousand Eight Hundred Fourteen Dollars (\$960,814). The grant funds a portion of public health nursing functions. The period of the grant is from July 1, 2005 to June 30, 2006.

The State of Alaska has granted funds to the Municipality of Anchorage for core public health services since 1966, when the Anchorage community voted for public health powers. This grant was established to fund those public health services provided elsewhere by the state government.

Under the terms of the grant, the Department of Health and Human Services will provide:

- population-based public health nursing services including immunizations, active and passive community disease surveillance, and building partnerships with community organizations;
- community health education and prevention (e.g., maternal and child health issues, communicable disease issues, personal preparedness and prevention);
- TB control services such as PPDs, chest x-rays, TB assessments, active and latent TB treatment, and contact investigations;
- epidemiological diagnosis and investigation of all city and state communicable disease reports with appropriate screening, contact tracing, testing, and treatment; and application of control measures;
- community and clinic visits to high risk pregnant women, infants, children and families;
- data collection, evaluation and reporting for services rendered; and
- maintenance of financial records which are readily accessible for state or federal review.
