A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FIFTY THOUSAND DOLLARS (\$50,000) FROM THE ANCHORAGE SCHOOL DISTRICT TO THE MISCELLANEOUS OPERATIONAL GRANTS FUND (261), DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR THE PROVISION OF THE COVENANT HOUSE ALASKA YOUTH RECEPTION CENTER PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of Fifty Thousand Dollars (\$50,000) is appropriated as a contribution from Anchorage School District funds to the Miscellaneous Operational Grants Fund (261), Department of Health and Human Services for the provision of Covenant House Alaska Youth Reception Center Program.

Section 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation of funds for the Covenant House Alaska Youth Reception Center Program.

The Department of Health and Human Services has received Fifty Thousand Dollars (\$50,000) from Anchorage School District for a grant to continue the Youth Reception Center Program.

This appropriation request is for a grant to Covenant House Alaska for the Youth Reception Center Program. This project provides a safe place for youth, who are in Anchorage Police Department (APD) custody, to stay until they can be released to a responsible adult or other arrangements are made. The offences do not require the youth to be held at McLaughlin Youth Center. Services are provided 24-hours seven days a week.

Covenant House Alaska is uniquely qualified to provide the needed services and is the only 24-hour non-profit youth agency available to provide services and meet the needs of both the youth, family, APD and the Anchorage School District. Covenant House conducts an intake assessment, contacts a responsible adult to pick-up the youth, develops plans and referral services to help the youth and/or the family address the reason(s) the youth was in custody and provides follow-up services to encourage positive outcomes.

This is a joint project by the Department of Health and Human Services, Anchorage Police Department, Anchorage School District, Municipal Light & Power and the Mayor's Office.
