GAMES (\$297,600)

The accompanying Assembly Resolution accepts and appropriates Two Hundred Ninety-Seven Thousand Six Hundred Dollars (\$297,600) of a U.S. Department of Education grant to the Municipality of Anchorage for services and improvements related to Anchorage's hosting of the 2006 National Veterans' Wheelchair Games.

An estimated 500 wheelchair athletes, all veterans, will compete in sixteen different events at multiple venues. The games are the world's largest annual wheelchair sporting event, and 2006 will be the 26<sup>th</sup> year of competition. The Mayor's Office will be working with the Veterans' Administration and its contractor as well as the games' organizing committee to prepare, plan, and coordinate capital improvements, services, and activities related to the games.

Some of the anticipated uses of the grant moneys are as follows: upgrade arctic entryways and doors to modern ADA-standards at the downtown transit center; purchase additional ADA-compliant portable toilets; resurface and upgrade spectator areas at the Anchorage Football Stadium; upgrade sidewalks and bus stops in the Chester Creek Sports Complex Area for better ADA accessibility; purchase of a riser ramp for wheelchair accessibility to a portable stage at Egan Convention Center; and payment of rental fees for use of Sullivan Arena for 2006 National Veterans' Wheelchair Games events.
