In accordance with Anchorage Municipal Code 21.15.133, the Office of Planning, Development & Public Works has requested this street name change. There are two streets named Timberline Drive within the Municipality of Anchorage; one in Girdwood, one in Eagle River. Letters were sent to all twelve property owners affronting this street asking for suggestions for a street name. Six property owners suggested Timber Ridge Drive, one suggested Bedrock Road. Property owners were then asked to vote on the suggested names. Six property owners voted for Timber Ridge Drive and no other votes were received. Comments opposing any change were submitted.

The Anchorage Municipal Code (21.15.133.D) requires the Clerk to schedule a public hearing on the matter before the Assembly. The question before the Assembly is whether or not to ratify the executive order.

BY ORDER OF THE MAYOR


Timberline Drive shall be named Timber Ridge Drive. This order shall be effective 30 days after issuance.



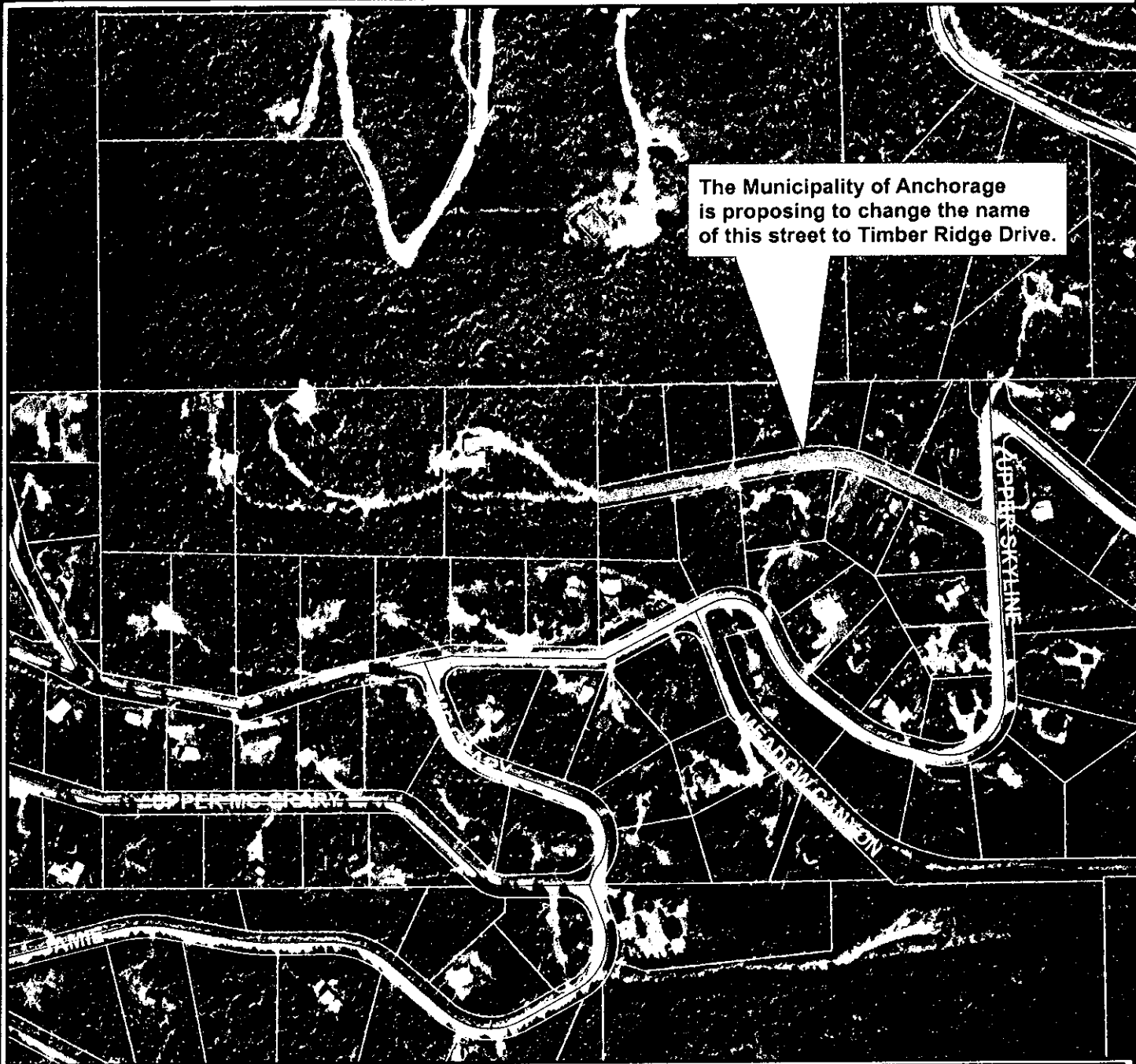

STREET NAME CHANGE PROPOSAL



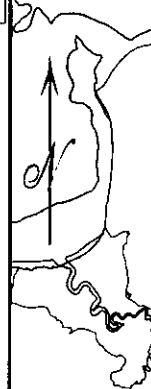
STREET NAME CHANGE PROPOSAL

Timberline Drive is considered a duplicate of a Timberline Drive in Girdwood. As duplicate street names may prove problematic during emergency response, the Municipality is working to eliminate them.

Letters were sent to all adjacent property owners asking for street name suggestions. We then asked property owners to vote on the suggested names, and Timber Ridge Drive won the vote. We are therefore proposing to change the name of this street to Timber Ridge Drive.

It is recommended that this street name change is approved.

Municipal Addressing has proposed the following street name change:

Explanation:

The Municipality of Anchorage has proposed to officially change the name of Timberline Drive in Eagle River to **Timber Ridge Drive**. Timberline Drive is considered a duplicate of Timberline Drive in Girdwood.

Municipal Addressing sent letters to all property owners along this street (12 total) asking for street name suggestions. We received 6 suggestions for Timber Ridge Drive and one suggestion for Bedrock Road. We then let property owners vote on the suggested names. The majority voted for **Timber Ridge Drive**. (6 property owners voted for Timber Ridge Drive, and we received no other votes.) We also received comments opposed to any change at all. All comments and votes received are attached.

As per Anchorage Municipal Code 21.15.133.C, the Director of the Planning Department shall submit the street name alteration to the Mayor with a recommendation for his approval or disapproval. It is respectfully requested that you approve this proposed street name alteration.

**PETITION AGAINST RENAMING
TIMBERLINE DRIVE, EAGLE RIVER**

This petition documents the strong opposition by the residents of Timberline Drive in Eagle River to being forced to change our street name. The municipality is requiring the name change for residents of Timberline Drive in Eagle River to avoid having the residents of Timberline Drive in Girdwood change their street name. The municipality has attempted to justify the change due to emergency 911 concerns.

We the undersigned object to this change for a number of reasons including, but not limited to, the following:

- With regard to precedence: Timberline Drive in Eagle River was platted prior to Timberline Drive in Girdwood.
- With regard to mailing addresses for the residents: Only those residing on Timberline Drive in Eagle River actually use street addresses which have been officially designated as such.
Timberline Drive residents of Girdwood use PO Boxes for mailing purposes, since, to date, they have no officially assigned street addresses.
- Requiring the residents of Timberline Drive in Eagle River to change their street name has far reaching consequences to those residents: These include the fees and inconvenience of changing all Alaska State licenses, including drivers license addresses, vehicle title & registration & personal property (for as many as five people per residence.) Printing new checks or writing the address change every time a check is written (as many as five checking accounts in one residence), as well as contacting all those people and organizations that affect our lives. Those of us in private business have the additional burden of the cost & inconvenience of reprinting business cards, stamps, address labels, stationery & more, and contacting our customers and business relations. State Business Licenses and everything relating to such business would also have to be changed. All of these changes result not only in a financial impact but require a great deal of time. When an inquiry was made as to who would pay for all these changes, we were told that we would be expected to bear this burden personally.
- Conversely, requiring the residents of Timberline Drive in Girdwood (many of whom are seasonal residents only) to change their street name has none of the above adverse effects. There would be no negative financial impact on those residents.

Since this appears to be an arbitrary decision by the Mayor, we strongly urge him to reconsider the ramifications of his decision. We pay taxes and should not be required to make this change when we legally platted our street name first.
