Continue the Revision of the Anchorage Coastal Management Plan

With the endorsement of the Municipal Assembly, the Planning Department has been implementing the Anchorage Coastal Management Program for many years. The State of Alaska has provided funding to the Municipality for staff support for required Coastal District tasks under the Coastal Management Program and occasionally for additional special projects.

The State of Alaska's Department of Commerce, Community, and Economic Development has recently forwarded to the Municipality a Coastal Management Program Grant for the special project in FY 2006. In 2004, the State made legislative changes to the Alaska Coastal Management regulations, which required all Alaska coastal districts to update their coastal management plans. This grant provides special project funds of \$40,100 to the Municipality to complete the revision of the current Anchorage Coastal Management Plan.

This \$40,100 pays for contractual, administrative, mapping, and printing/distributing costs involved in the evaluation of the ACMP. No match money is required.
