1 AN ORDINANCE EXTENDING THE TERM OF THE BIRCH TREE/ELMORE LIMITED ROAD
2 SERVICE AREA, RETROACTIVE TO JANUARY 1, 2006, UNTIL JUNE 1, 2006, OR UNTIL
3 EXTENDED BY QUALIFIED VOTERS RESIDING IN THE SERVICE AREA AT THE NEXT
4 REGULAR MUNICIPAL ELECTION ON APRIL 4, 2006.

7 WHEREAS, Birch Tree/Elmore Limited Road Service Area was created by Anchorage Ordinance 81-117;
8 and
9

10 WHEREAS, qualified voters residing in said limited service area voted at the April 2, 2002 Regular
11 Municipal Election to continue the limited road service area until December 31, 2005; and
12

13 WHEREAS, the question of whether to continue the limited road service area failed to be placed on the
14 ballot at the April 5, 2005 Regular Municipal Election; and

16 WHEREAS, the limited road service area expires on December 31, 2005; now, therefore,

18 THE ANCHORAGE ASSEMBLY ORDAINS:

20 **Section 1.** Notwithstanding Anchorage Municipal Code section 27.10.015C., section 27.30.290 is
21 amended to read as follows:
22

23 **27.30.290** **Birch Tree/Elmore Limited Road Service Area**
24

25 A. There is a limited road service area within the municipality known as the Birch
26 Tree/Elmore Limited Road Service Area to provide limited road maintenance and repair to
27 the area described on the map located in section 27.30.700.
28

29 B. Limited road maintenance and repair within the service area shall commence on January 2,
30 1982 and shall end on June 1, 2006 [DECEMBER 31, 2005] unless the service area is
31 extended by an affirmative vote in the area affected at the regular election of April 2006
32 [2005]. The mill rate for the service area shall not exceed 1.5 mills in any calendar year.

38 **Section 2.** In the event the voters within the Birch Tree/Elmore Limited Road Service Area fail to
39 extend the service area after June 1, 2006 and, after all limited road service area financial obligations are
40 paid, including services provided in 2006 prior to termination, any remaining service area taxes collected

1 shall be returned, on a prorated basis, to service area property owners as of the date of the termination of
2 the service area.

4 **Section 3.** This ordinance shall be effective retroactively to January 1, 2006.
