1 AN ORDINANCE EXTENDING THE TERM OF THE SOUTH GOLDENVIEW AREA LIMITED  
2 ROAD SERVICE AREA, RETROACTIVE TO JANUARY 1, 2006, UNTIL JUNE 1, 2006, OR  
3 UNTIL EXTENDED BY QUALIFIED VOTERS RESIDING IN THE SERVICE AREA AT THE  
4 NEXT REGULAR MUNICIPAL ELECTION ON APRIL 4, 2006.

5  
6 WHEREAS, the South Goldenview Area Limited Road Service Area was created by Anchorage  
7 Ordinance 81-116; and

8  
9 WHEREAS, qualified voters residing in said limited service area voted at the April 2, 2002 Regular  
10 Municipal Election to continue the limited road service area until December 31, 2005; and

11  
12 WHEREAS, the question of whether to continue the limited road service area failed to be placed on the  
13 ballot at the April 5, 2005 Regular Municipal Election; and

14  
15 WHEREAS, the limited road service area expires on December 31, 2005; now, therefore,

16  
17 THE ANCHORAGE ASSEMBLY ORDAINS:

18  
19 **Section 1.** Notwithstanding Anchorage Municipal Code section 27.10.015C., section 27.30.280 is  
20 amended to read as follows:

22 **Section 27.30.280** **South Goldenview Area Limited Road Service Area**

- 23  
24 A. There is a limited road service area within the municipality known as the South  
25 Goldenview Area Limited Road Service Area to provide limited road maintenance  
26 and repair to the area described on the map located in section 27.30.700.  
27  
28 B. Limited road maintenance and repair within the service area shall [COMMENCE ON  
29 JANUARY 2, 1982 AND SHALL] end on June 1, 2006 [December 31, 2005], unless  
30 the service area is extended by an affirmative vote of the area affected at the regular  
31 election of April 2006 [2005]. The mill rate shall not exceed 1.80 mills in any  
32 calendar year.  
33  
34 C. Effective January 1, 2004, Shangri-La Subdivision, which includes Lost Horizon  
35 Drive, Shangri-La Circle and Sandpiper Drive, was added to and included in the  
36 boundaries of the South Goldenview Area LRSA.

 2 **Section 2.** In the event voters within the South Goldenview Area Limited Road Service Area fail to  
 3 extend the service area after June 1, 2006 and, after all limited road service area financial obligations  
 4 are paid, including services provided in 2006 prior to termination, any remaining service area taxes  
 5 collected shall be returned, on a prorated basis, to service area property owners as of the date of the  
 6 termination of the service area.

7  
 8 **Section 3.** This ordinance shall be effective retroactively to January 1, 2006.
