AN ORDINANCE SETTING THE RATE OF TAX LEVY FOR THE GENERAL GOVERNMENT AND  
LEVYING TAXES FOR THE MUNICIPALITY OF ANCHORAGE AREAWIDE GENERAL PURPOSES  
INCLUDING ALL SERVICE AREAS OF THE MUNICIPALITY AND EXCLUDING MUNICIPAL  
SCHOOLS FOR THE MUNICIPAL TAX YEAR 2006 AND APPROVING THE AMOUNT OF  
MUNICIPAL GENERAL GOVERNMENT PROPERTY TAX FOR FISCAL YEAR 2006.

THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1.** That the Assembly hereby fixes the rate of tax levy for the general government of the  
Municipality for the tax year 2006 for Areawide General Purposes including all service areas of the  
Municipality. The Anchorage Assembly levies this tax upon the full value of all assessed taxable real  
and personal property, as follows.

**Section 2.** Areawide General a tax of .46 mills

**Section 3.** City Service Area a tax of .02 mills

**Section 4.** Chugiak Fire Service Area a tax of .91 mills

**Section 5.** Glen Alps Service Area a tax of 2.44 **2.75** mills

**Section 6.** Girdwood Valley Service Area a tax of 3.97 mills

**Section 7.** Service Area 35 - Roads & Drainage Debt a tax of 0.00 mills

**Section 8.** Birch Tree/Elmore Limited Road Service Area a tax of 1.34 **1.50** mills

**Section 38.** The property tax amount approved for 2006 (the "amount approved by the Assembly for the preceding year" to be used in the determination of the 2007 tax limitation) as defined by Anchorage Municipal Code subsection 12.25.040, including real property and personal property taxes, excluding those service areas with voter-approved maximum tax rates, are as follows:


Municipal General Government \$ 194,866,720

Anchorage School District as levied with AO 2006 – 58 \$ 184,379,645


Total Municipal Property Taxes Approved for 2006 \$ 379,246,365
