 Section 2. Anchorage Municipal Code section 27.30.320 is amended to read as follows:

27.30.320 Skyranch Estates Limited Road Service Area.

- A. There is a limited road service area within the municipality known as the Skyranch Estates Limited Road Service Area to provide limited road maintenance and repair to the area described on the map located in section 27.30.700.
- B. Limited road service maintenance and repair within the service area shall end on December 31, <u>2010</u> [2007], unless the service area is extended by an affirmative vote of the service area at the regular election of April <u>2010</u> [2007]. The mill rate shall not exceed 1.3 mills in any calendar year.
