1 AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE  
2 VALLI VUE LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL  
3 ELECTION APRIL 3, 2007 A BALLOT PROPOSITION APPROVING THE  
4 CONTINUATION OF THE LIMITED ROAD SERVICE AREA FOR AN  
5 ADDITIONAL PERIOD OF THREE YEARS AND AMENDING ANCHORAGE  
6 MUNICIPAL CODE SECTION 27.30.310 ACCORDINGLY.

8 WHEREAS the Valli Vue Limited Road Service Area was created by Anchorage  
9 Ordinance 83-81; and

11 WHEREAS, a showing of interest by persons residing in the limited road service  
12 area (LRSA) to continue the LRSA beyond December 31, 2007 has been made to  
13 the Municipality; now therefore,

15 THE ANCHORAGE ASSEMBLY ORDAINS:

17 **Section 1.** A ballot proposition in substantially the following form shall be  
18 submitted to the qualified voters residing in the Valli Vue Limited Road Service Area  
19 at the regular Municipal election on April 3, 2007:

**Section 2.** Anchorage Municipal Code section 27.30.310 is amended to read as follows:

**27.30.310 Valli Vue Limited Road Service Area.**

- A. There is established a limited road service area within the municipality known as the Valli Vue Limited Road Service Area to provide limited road maintenance and repair to the area described on the map locate in section 27.30.700.
- B. Limited road service maintenance and repair within the service area shall end on December 31, 2010 [2007], unless the service area is extended by an affirmative vote of the service area at the regular election of April 2010 [2007]. The mill rate shall not exceed 1.4 mills in any calendar year.



**Section 3.** Except **Section 2**, this ordinance shall become effective upon passage and approval. **Section 2** and the proposition contained in **Section 1** shall become effective upon certification of the regular election on the proposition called for by this ordinance, but only if the proposition is approved by a majority of the qualified voters voting on the proposition.
