

A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND HONORING KELLY LORAN FOR HIS 15 YEARS OF SERVICE WITH THE MUNICIPALITY OF ANCHORAGE

WHEREAS, Kelly Loran began his employment with the Department of Public Works Building Safety Division as an electrical inspector on December 3, 1990; and

WHEREAS, during his tenure, he also assumed responsibility for 40 building inspector fleet vehicles, coordinating fleet services, and rotating vehicles to maximize mileage prior to full depreciation; and

WHEREAS, Kelly's proactive efforts significantly improved the replacement cycle and availability of operable vehicles; and

WHEREAS, in March 2004, Kelly expanded his responsibilities by adding elevator inspections to his list of electrical inspections working with both municipal contractors and other professionals inspecting new/remodeled elevators and performing annual inspections; and

WHEREAS, Kelly provided assistance with the inspections process revisions, notification of elevator safety violations, and follow-up on cases to insure corrections were completed; and

WHEREAS, in addition to Kelly's dedication to his job, he was also willing to go that "extra mile" to represent his peers when he stepped forward to serve as Shop Steward for the electrical inspectors shortly after transition from the JCC to the IBEW; and

WHEREAS, most recently, Kelly was appointed Chief Shop Steward and has worked well with both the employees he represents and the Administration.
