Subject: Appropriation of \$2,400,000 for the Anchorage Domestic Violence Prevention

Project II

The Department of Health and Human Services (DHHS) received a grant award from the U.S. Department of Justice, Office on Violence Against Women for Two Million Four Hundred Thousand Dollars (\$2,400,000) to be appropriated to the Federal Categorical Grants Fund (241) for the Anchorage Domestic Violence Prevention Project II.

This project will increase offender accountability by adding two (2) officers to the Anchorage Police Department (APD) domestic violence unit to increase investigation and warrant service; funding three (3) domestic violence misdemeanor clerks to monitor offender compliance with bail conditions and/or post conviction judgments, and one (1) data entry position to expedite information transfer. A new position (1) through the Municipal Information Technology Department will work with DHHS to improve and expand communication systems between police, prosecution and court officials by developing hardware and software necessary for the systematic gathering, analyzing and sharing of necessary data. A .5 FTE Project Manager and a .5 FTE statistician at DHHS will analyze data to assess direct impact on arrest, warrant service, prosecution and compliance to evaluate the successful integration of services that increase offender accountability. DHHS and APD, in partnership with Abused Women's Aid In Crisis (AWAIC), will develop protocols and practices to provide victims with assessment, information and referral, as well as offer emergency financial aid for items such as safe housing, transportation, medical care and food.

The period of this grant is from October 1, 2005 through September 30, 2008.
