Coordination Grant and local match required. (\$97,880)

The Municipality of Anchorage has received a grant from the Department of Justice, Community Capacity Development Office, Russian Jack/Muldoon Weed & Seed Site Office for a Weed & Seed Coordination Program. The Russian Jack/Muldoon Weed & Seed Site Office has received a federal grant to reduce the occurence of violent and drug related criminal activities in the subject area. One of the identified problems sought to be addressed by this pass-through grant is the infrequency of prioritized sworn officer patrols in this relative high crime area.

This grant funding will be used to reimburse sworn officer overtime up to 832 hours immediately through March 31, 2006 and an additional 756 hours for the period of April 1, 2006 through September 30, 2006. This grant will provide increased, focused overtime patrol efforts to reduce gun violence and illegal drug operations in the Russian Jack/Muldoon program site area. The increased presence of patrol officers in and around these targeted housing areas will deter violent or drug related criminal activities while offering the residents an increased sense of security and safety.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$3,380, which has been budgeted in the 2006 Police Operating Budget. This grant begins immediately and will end on September 30, 2006.
