A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF NINETY FOUR THOUSAND FIVE HUNDRED DOLLARS (\$94,500) FROM THE DEPARTMENT OF JUSTICE, COMMUNITY CAPACITY DEVELOPMENT OFFICE, RUSSIAN JACK/MULDOON WEED & SEED SITE OFFICE AND THREE THOUSAND THREE HUNDRED EIGHTY DOLLARS (\$3,380) AS A CONTRIBUTION FROM THE 2006 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE FEDERAL CATEGORICAL GRANTS FUND (241) ANCHORAGE POLICE DEPARTMENT, FOR THE WEED & SEED PROGRAM COORDINATION GRANT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of NINETY FOUR THOUSAND FIVE HUNDRED DOLLARS (\$94,500), is appropriated from the Department of Justice, Community Capacity Development Office, Russian Jack/Muldoon Weed & Seed Site Office to the Federal Categorical Grants Fund (241), Anchorage Police Department, for a Weed & Seed program coordination grant.

Section 2. That the sum of THREE THOUSAND THREE HUNDRED EIGHTY DOLLARS (\$3,380), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2006 Anchorage Police Department Operating Budget as a contribution to the Federal Categorical Grants Fund (241), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the Department of Justice, Community Capacity Development Office, Russian Jack/Muldoon Weed & Seed Site Office, of a Weed & Seed Program Coordination Grant and local match required. (\$97,880)

The Municipality of Anchorage has received a grant from the Department of Justice, Community Capacity Development Office, Russian Jack/Muldoon Weed & Seed Site Office for a Weed & Seed Coordination Program. The Russian Jack/Muldoon Weed & Seed Site Office has received a federal grant to reduce the occurrence of violent and drug related criminal activities in the subject area. One of the identified problems sought to be addressed by this pass-through grant is the infrequency of prioritized sworn officer patrols in this relative high crime area.

This grant funding will be used to reimburse sworn officer overtime up to 832 hours immediately through March 31, 2006 and an additional 756 hours for the period of April 1, 2006 through September 30, 2006. This grant will provide increased, focused overtime patrol efforts to reduce gun violence and illegal drug operations in the Russian Jack/Muldoon program site area. The increased presence of patrol officers in and around these targeted housing areas will deter violent or drug related criminal activities while offering the residents an increased sense of security and safety.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$3,380, which has been budgeted in the 2006 Police Operating Budget. This grant begins immediately and will end on September 30, 2006.
