WHEREAS, the Department of Solid Waste Services (SWS) has Two Hundred Seventy-Seven Thousand Six Hundred Dollars (\$277,600) generated from the One Dollar (\$1.00) per ton tipping fee in the 2006 Disposal Operating Budget (Fund 562); and

WHEREAS, SWS has been funding the wages and benefits of the Renewable Resources Manager located in the Office of Economic and Community Development (OECD) and a variety of recycling activities pursuant to the MOA Waste Reduction and Recycling Management Plan established by former Mayor Rick Mystrom in 1997; and

WHEREAS, SWS will transfer the above amount to OECD for the purpose of funding the wages and benefits of the Renewable Resources Manager for the remainder of 2006, the 2006 recycling grants and other recycling and waste reduction activities; and

NOW THEREFORE, the Anchorage Assembly resolves:

That Two Hundred Seventy-Seven Thousand Six Hundred Dollars (\$277,600) from SWS 2006 Disposal Operating Budget (Fund 562) is hereby appropriated as a contribution to OECD 2006 General Government Operating Budget (Fund 101).

Section 2. That this resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: A Resolution appropriating Two Hundred Seventy-Seven Thousand Six Hundred Dollars (\$277,600) from the Department of Solid Waste Services 2006 Disposal Operating Budget (Fund 562) as a contribution to the Office of Economic and Community Development 2006 General Government Operating Budget (Fund 101) for the Renewable Resources (Recycling) Program.

Solid Waste Services (SWS) charges \$45 per ton for the disposal of refuse at the Central Transfer Station and Anchorage Regional Landfill. \$1.00 per ton is set aside for recycling and waste reduction related activities as specified in the MOA Waste Reduction and Recycling Management Plan established by former Mayor Rick Mystrom in 1997.

Since 1997, SWS has funded a variety of recycling and waste reduction activities through the Recycling Challenge Grant program as well as direct grants to such projects as the annual Christmas tree recycling, the Youth Litter Patrol, and wharfage to ship recyclables out of state. This money has also been used to fund the wages and benefits of the Municipal Renewable Resources Manager and the Municipal mixed-paper recycling which is processed by SWS.

SWS is in agreement to transfer funding and responsibilities of the municipal recycling projects to the Office of Economic and Community Development. The Renewable Resources Manager will be responsible for selection of and funding of various recycling and waste reduction programs.
