**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS TEMPORARY NON OBJECTION TO MINOR AMENDMENT OF THE EXISTING CONDITIONAL USE PERMIT, ISSUANCE OF DUPLICATE BEVERAGE DISPENSARY LICENSES AND TRANSFER OF CORPORATE OWNERSHIP TO PLATINUM JAXX, INC., OPERATING AT 901 WEST 6<sup>TH</sup> AVENUE/538 I STREET, ORIGINAL TOWNSITE, BLOCK 55, LOTS 10 & 12 A.**

WHEREAS, Platinum Jaxx, Inc. has made application with the Alcoholic Beverage Control Board and has paid the required fee for two duplicate alcoholic beverage dispensary licenses; and

WHEREAS, Platinum Jaxx, Inc. has made application with the Municipality of Anchorage and has paid the required fees for a minor amendment to the existing conditional use permit, required as a result of the duplicate licenses; and

WHEREAS, the amendment to the conditional use permit, application for duplicate licenses, and a corporate transfer of ownership are scheduled for Assembly review at the March 14, 2006 Assembly meeting; and

WHEREAS, Platinum Jaxx, Inc. has made the establishment available for walk-through and review by Assembly members; and

WHEREAS, Platinum Jaxx, Inc. representatives and owners have attended an Assembly Work Session on February 24, 2006, and responded to questions and concerns of the Assembly and the public,

NOW, THEREFORE, the Anchorage Assembly RESOLVES:

**Section 1.** This body does not protest the issuance of duplicate beverage dispensary liquor licenses #4551 and #4552 for Platinum Jaxx, Inc. at the 901 West 6<sup>th</sup> Avenue/538 I Street, Anchorage, Alaska location.

**Section 2.** Platinum Jaxx, Inc. is hereby granted a temporary minor amendment to the existing conditional use permit for the sale of alcoholic beverages subject to the provisions of state law (title 4) and the requirements of the Municipal ordinances dealing with conditional uses and the sale of alcoholic beverages.

**Section 3.** A copy of this resolution may be presented to the Alcoholic Beverage Control Board as proof that the Anchorage Assembly, as the local governing body, has issued this temporary minor amendment to the conditional use permit and stated its non objection to the issuance of duplicate beverage dispensary licenses, and its temporary non objection to the corporate transfer of ownership, in order to permit the Director of the Alcoholic Beverage Control Board to issue temporary approval of the license.

**Section 4.** This resolution is subject to the terms of the required conditional use of this location.
