A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) AS A DONATION FROM THE ANCHORAGE PARK FOUNDATION TO THE ANCHORAGE PARKS AND RECREATION AREA CAPITAL IMPROVEMENT FUND, (461) FOR THE CONSTRUCTION OF A PAVILION, SLEDDING HILL AND PLAYGROUND EQUIPMENT AT ABBOTT LOOP COMMUNITY PARK.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of Two Hundred Fifty Thousand Dollars (\$250,000) is hereby appropriated as a donation from the Anchorage Park Foundation to the Anchorage Parks and Recreation Service Area Capital Improvement Fund, (461) for the construction of a pavilion, sledding hill, and playground equipment at Abbott Loop Community Park.

Section 2. That this resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

8 Last winter Wells Fargo made a generous contribution of Two Hundred Fifty Thousand Dollars (\$250,000) to
9 the Anchorage Park Foundation to fund construction of a picnic pavilion, sledding hill, and playground
10 equipment for the Abbott Loop Community Park. The pavilion design is underway and it is time for Project
11 Management & Engineering to encumber funds for spring/summer 2006 construction.

13 Thank you to Richard Strutz and Wells Fargo Bank for investing in this community park. We hope this private
14 investment for public good will be recognized and celebrated by neighbors and families who will enjoy the
15 beauty of this public space. Investments in Anchorage parks are investments in the health and future of our
16 community.

18 This is only the first request for appropriation of Anchorage Park Foundation funds. This new foundation is a
19 promising development for Anchorage parks and trails, and as the Anchorage Park Foundation grows local
20 philanthropy opportunities, the Anchorage Assembly welcomes this participation in the process of improving
21 Anchorage.
