Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Drug Recognition Expert Instructor Course Program Grant and local match required. (\$7,155)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a Drug Recognition Expert Instructor Course program. This grant will be used to provide Drug Recognition Expert Instructor Certification to two Traffic Unit officers during the period May 14, 2006 thru May 22, 2006.

This grant will be used to reimburse travel and training costs related to the Drug Recognition Expert Instructor Course to be performed in Las Vegas, Nevada. This training will allow the two officers that attended DRE training in January of 2006 to complete the Drug Recognition Expert Instructor Certification program. Once certified, these officers will be able to certify additional sworn officers to obtain warrants for chemical blood testing in traffic stops where no signs of alcohol are present. Through increased awareness and enforcement of impaired driving violations, the citizens of Anchorage will experience safer roads and reduced traffic injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$2,919, which has been budgeted in the 2006 Police Operating Budget. This grant began on May 1, 2006 and will end on June 30, 2006.
