**A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE RECOGNIZING AND
HONORING CLIFTON DERRICK III AND RUSSELL DERRICK FOR THEIR LIFE SAVING
EFFORTS.**

WHEREAS, on January 2, 2006 Clifton Derrick III and Russell Derrick were instrumental in saving the life of a driver involved in a tragic accident on the Seward Highway; and

WHEREAS, after being passed by a truck traveling at a high rate of speed, Clifton and Russell came upon wreckage of an accident that occurred only seconds earlier resulting in one of the involved vehicles exiting the roadway and traveling down an embankment; and

WHEREAS, Russell immediately called 911 and Clifton climbed down the embankment to find the sole occupant dazed and confused in the drivers seat as an engine fire was observed that would soon engulf the vehicle; and

WHEREAS, Clifton directed the occupant to exit the vehicle through the passenger window and assisted him back up the embankment to safety; and

WHEREAS, through Clifton and Russell's quick actions and willingness to become involved, the occupant of the distressed vehicle was saved from being a victim of the fire; and

NOW, THEREFORE, the Anchorage Municipal Assembly resolves that

CLIFTON DERRICK III and RUSSELL DERRICK

Are recognized and honored by the Employee Recognition Board, Anchorage Police Department, and the Municipality of Anchorage for their life saving effort and outstanding contribution to the community.
