This grant will be used to reimburse travel and conference costs related to the Drug Recognition Expert Annual Training Conference to be held in Kansas City, Missouri. This annual training conference will provide advanced drug recognition training to seven Traffic Unit officers and the agency coordinator. Training will include topics such as horizontal gaze nystagmus, illegal drugs and driving, establishing DUI checkpoints, and the dynamics of an impaired driving trial.
