Supplemental Grant Award for Community Health Nursing Services

The Department of Health and Human Services has received a supplemental grant award from the Alaska Department of Health and Social Services in the amount of Fifteen Thousand Dollars (\$15,000). The grant supplements an original award of \$960,814. The grant funds a portion of community health nursing functions. The period of the grant is from July 1, 2005, to June 30, 2006.

The State of Alaska has granted funds to the Municipality of Anchorage for core public health services since 1966, when the Anchorage community voted for public health powers. This grant was established to fund those public health services provided elsewhere by the state government.

Under the terms of the grant, the supplemental funds shall be used to:

- fund increased mileage expenses associated with automobile travel to and from offsite clinics and client visit sites for the purpose of providing tuberculosis treatment services;
- purchase routine supplies necessary to the provision of TB control services; and
- develop, promote, and implement a tuberculosis educational training program to be provided at no charge to community health care providers.
