

ANCHORAGE, ALASKA AR No. 2006- 108

A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING WHEN TENDERED EIGHT HUNDRED SEVENTY FOUR THOUSAND DOLLARS (\$874,000) FROM THE FEDERAL AVIATION ADMINISTRATION AIRPORT IMPROVEMENT PROGRAM GRANT, AND TWENTY THREE THOUSAND DOLLARS (\$23,000) FROM THE STATE OF ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES GRANT; AND APPROPRIATING SAID GRANTS AND TWENTY THREE THOUSAND (\$23,000) FROM AIRPORT UNRESTRICTED NET ASSETS TO MERRILL FIELD'S CAPITAL IMPROVEMENT FUND FOR THE 2006 MERRILL FIELD REHABILITATE APRONS (PHASE-1), AND SECURITY UPGRADES (GATE IMPROVEMENTS).

WHEREAS, in anticipation of the Federal Aviation Administration offering the Municipality of Anchorage a grant of funds in the amount of Eight Hundred Seventy Four Thousand Dollars (\$874,000); and

WHEREAS, in anticipation of the State of Alaska offering the Municipality of Anchorage a grant of funds in the amount of Twenty Three Thousand Dollars (\$23,000); and

WHEREAS, the grant amounts will be adjusted by the granting agencies to actual expenditures at time of closing; and

WHEREAS, there is a need for these projects at Merrill Field.

NOW, THEREFORE, BE IT RESOLVED, by the Assembly of the Municipality of Anchorage:

<u>Section 1</u>. That the Municipality of Anchorage hereby accepts, when tendered, the Federal Aviation Administration (FAA) Grant offer of Eight Hundred Seventy Four Thousand Dollars (\$874,000) and hereby undertakes and agrees to use those funds for the 2006 Merrill Field Rehabilitate Aprons (Phase-1), and Security Upgrades (Gate Improvements).

<u>Section 2.</u> That the Municipality of Anchorage hereby accepts, when tendered, the State of Alaska Department of Transportation and Public Facilities (SOA DOT&PF) grant for Twenty Three Thousand Dollars (\$23,000), and appropriates both grants and Twenty Three Thousand Dollars (\$23,000) from airport unrestricted net assets to Merrill Field's Capital Improvement Fund.

<u>Section 3.</u> The Mayor, or Municipal Manager, is authorized to execute an agreement with the FAA and with the SOA DOT&PF and provide information as may be required of the Municipality of Anchorage.

Subject: United States Department of Transportation, Federal Aviation Administration has

allocated Federal Funds to the Municipality of Anchorage for the 2006 Merrill Field

Rehabilitate Apron (Phase-1) & Security Upgrade (Gate Improvements)

Merrill Field Airport anticipates receiving a grant of \$874,000 for the 2006 Merrill Field Rehabilitate Apron (Phase-1) & Security Upgrade (Gate Improvements) from the United States Department of Transportation, Federal Aviation Administration.

Merrill Field Airport also anticipates receiving \$23,000 in grant matching funds from the State of Alaska for these improvements. The Municipality of Anchorage's matching share of \$23,000 will come from Merrill Field Unrestricted Net Assets.

It is recommended that the FAA and State grant offers be accepted, when tendered, in the amount of \$874,000 and \$23,000 respectively and said grants and \$23,000 from airport unrestricted net assets be appropriated to the Merrill Field Capital Improvement Fund. Acceptance by the Assembly is contingent upon receipt of FAA grant.
