1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND APPROPRIATING
2 ONE MILLION SEVEN HUNDRED TWO THOUSAND ONE HUNDRED AND EIGHTY-NINE
3 DOLLARS (\$1,702,189) AS A FEDERAL TRANSIT ADMINISTRATION SAFETEA-LU GRANT TO
4 THE ANCHORAGE PARKS AND RECREATION SERVICE AREA CAPITAL IMPROVEMENT
5 PROJECTS FUND (461) FOR FACILITY IMPROVEMENTS TO ACCOMMODATE THE 2006
6 NATIONAL VETERANS' WHEELCHAIR OLYMPIC GAMES

8 WHEREAS, Anchorage has been selected as the site for the 2006 National Veterans' Wheelchair
9 Olympic Games; and,

11 WHEREAS, improvements are needed at Anchorage Football Stadium to accommodate handi-
12 capped and wheelchair access; and,

14 WHEREAS, the Municipality of Anchorage received an allocation of funding in the Federal
15 SAFETEA-LU appropriation for "handicapped and pedestrian access construction, surfacing and
16 other improvements for 2006 National Veterans' Wheelchair Games"; and

18 WHEREAS, the Federal Transit Administration is the funding agency through whom a grant is now
19 being provided to the Municipality of Anchorage for 2006 National Veterans' Wheelchair Olympic
20 Games; now, therefore,

22 **THE ANCHORAGE ASSEMBLY RESOLVES:**

24 **Section 1.** That the Administration is authorized to accept a Federal Transit Administration grant
25 for facility improvements to accommodate the 2006 National Veterans' Wheelchair Olympic
26 Games.

28 **Section 2.** That the sum of One Million Seven Hundred Two Thousand One Hundred Eighty-nine
29 Dollars (\$1,702,189) is hereby accepted and appropriated as a grant from the Federal Transit Ad-
30 ministration to the Anchorage Parks and Recreation Service Area Capital Improvement Projects
31 Fund (461) to fund access improvements to facilities required for the 2006 National Veterans'
32 Wheelchair Olympic Games.

34 **Section 3.** That this resolution shall take effect immediately upon passage and approval by the
35 Anchorage Assembly.

Subject: Accepting and appropriating \$1,702,189 as a Federal Transit Administration Safe, Accountable, Flexible, Efficient Transportation Equity Act (SAFETEA-LU) 2006 Earmark grant for Facility Improvements necessary to host the 2006 National Veterans' Wheelchair Olympic Games

The funds will be expended for ADA accessible facilities at the Anchorage Football Stadium for the 2006 National Veteran's Wheelchair Olympic Games.

These funds will provide an upgrade of the existing Anchorage Football Stadium and track at the Chester Creek Sports Complex. In addition to the track, two adjacent facilities in the Sports Complex (Sullivan Arena and Ben Boeke Arena) will serve as games venues. The track needs resurfacing and removal of concrete curbs to meet Games standards. The new track, additional paving, sidewalks, and ramps for athletes and spectators alike will necessitate substantial drainage improvements. Additional required upgrades include ADA accessible bleachers.
