Subject: Appropriation of a contribution from the Zylon Settlement Administrator, Zylon Litigation Settlement Fund (\$112,420)

The Administration requests Assembly approval for the appropriation of a contribution of \$112,420 from the Zylon Settlement Administrator, Zylon Litigation Settlement Fund for use by the Municipality of Anchorage, Anchorage Police Department.

In September of 2005, the Anchorage Police Department joined a class action lawsuit initiated by the City of Pryor Creek, Oklahoma against Second Chance Body Armor and Toyobo Company, LTD for their role in the manufacture and marketing of ballistic body armor containing the material Zylon. A settlement was reached with Toyobo Company, LTD in which the amount of \$29,000,000 was deposited in an escrow account entitled the Zylon Litigation Settlement Fund. This contribution represents the departments pro-rata share of \$730 per vest multiplied by the 154 vests purchased containing the Zylon material.

These funds will be utilized to offset the incurred costs of replacement ballistic vests and additional new vests to be purchased for the sworn officers of the Anchorage Police Department. There is no Municipal fund match requirement for this contribution. There is no specific time frame for expenditure of contribution funds.
