Alaska Housing Finance Corporation (AHFC) Homeless Management Information System

(HMIS) Cooperative Service Agreement appropriation.

The attached resolution is to appropriate Fifty-five Thousand Dollars (\$55,000) from Alaska Housing Finance Corporation to State Categorical Grants Fund (231), Department of Health and Human Services for the purpose of providing AHFC and other AHFC approved agencies outside of the Municipality of Anchorage (MOA) with access to the MOA hosted web based HMIS also know as the LINK Project.

The LINK Project is funded in part by the U.S. Department of Housing and Urban Development (HUD) Continuum of Care Supportive Housing Program and AFHC matching funds. This Cooperative Service Agreement will allow AHFC and MOA to expand the HMIS to a statewide database for the collection of accurate and timely statistics related to the homeless population as mandated by Congress. In addition, participating organizations will have a needed tool for case management, referrals, and client tracking.

The funding period is December 1, 2005 through December 1, 2007 which includes the first agreement year plus an option year.

This appropriation will allow the Department of Health and Human Services (DHHS) to share their knowledge and expertise of this technology project statewide. DHHS will host the HMIS website; provide training and help desk support; and cover licenses and fees of not more than 35 individual users.
