(\$201,870) from the Eagle River-Chugiak Parks and Recreation Service Area Fund (162), Office of Economic and Community Development's Eagle River-Chugiak Parks, Recreation and Community Development Division's 2006 Operating Budget. as a Contribution to the Eagle River Parks and Recreation Service Area Capital

Improvement Project Fund (462) for Capital Improvements.

In April 2004, voters from the Eagle River-Chugiak Parks and Recreation Service Area approved a new \$0.50 mill rate to generate annual capital funds for parks and recreation improvements. These revenues are collected and deposited into the Eagle River-Chuqiak Parks and Recreation Service Area's operating fund (162).

On February 28, 2006, AR2006-56 appropriated \$1,239,350 from the operating fund (162) as a contribution to the Eagle River Chugiak Parks and Recreation Capital Improvement Project Fund (462) based on estimates available at the time of the adopted 2006 budget.

By enacting AR 2006- 148, an additional \$201,870 will be appropriated from the operating fund (162) for a total contribution of \$1,441,220 to the Eagle River-Chugiak Parks and Recreation Capital Improvement Project Fund (462) reflecting 2006 Assessed valuations.
