A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWO HUNDRED THOUSAND DOLLARS (\$200,000) FROM THE GIRDWOOD VALLEY SERVICE AREA FUND (106), ANCHORAGE PARKS AND RECREATION DEPARTMENT 2006 OPERATING BUDGET, AS A CONTRIBUTION TO THE GIRDWOOD VALLEY CAPITAL IMPROVEMENT PROJECT FUND (406) FOR THE NEW GIRDWOOD COMMUNITY CENTER AND LIBRARY PROJECT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of Two Hundred Thousand Dollars (\$200,000) is appropriated from the Girdwood Valley Service Area Fund (106), Anchorage Parks and Recreation Department 2006 Operating Budget, as a Contribution to the Girdwood Valley Service Area Capital Improvement Project Fund (406) for the purpose of a new Girdwood Community Center and Library.

At the request of the Girdwood Board of Supervisors, the Anchorage Assembly included \$200,000 in the 2006 first quarter budget revisions for the Anchorage Parks and Recreation Department's 2006 Girdwood Service Area operating budget. These funds are to be contributed from the Girdwood Valley Service Area Fund (106) to the Girdwood Valley Service Area Capital Improvement Projects Fund (406) for the purpose of the future construction of a new Girdwood Community Center and Library.
