WHEREAS, Kenneth E. Peavyhouse lived in Alaska since 1959, residing in Gustavus, Juneau, Kotzebue, Cold Bay, King Salmon, Valdez and since 1979 in Anchorage; and

WHEREAS, Mr. Peavyhouse served in the United States Navy as a destroyer radioman from 1950 until his honorable discharge in 1954; and

WHEREAS, Mr. Peavyhouse served in several careers, including the Federal Aviation Administration, as air traffic controller, operations inspector and tower chief from 1955 until retirement in 1981, Mutual of New York Life Insurance Company from 1981 to 1995, and AERO Forensics since 1983 as an aviation legal consultant; and

WHEREAS, Mr. Peavyhouse served many Alaskan communities and organizations including Valdez Transportation Commission (1975-1977), Alaska Coastal Zone Policy Council (1975-1979), Prince William Community College Advisory Board (1975-1979), City of Valdez as councilman (1977-1979) and mayor pro-tem (1978-1979), Alaska State Board of Marine Pilots (1979-1984), Alaska Airman's Association (1988-1995), Alaska Commission on Judicial Conduct (1991-2006), Resource Development Council Board (1980-2006), and Access Alaska Board (1993-1999); and

WHEREAS, Mr. Peavyhouse served the Municipality of Anchorage on the Municipal Board of Ethics (1981-1985 and 2002-2005), Anchorage Zoning Appeals Board (1986-1989), Anchorage Planning and Zoning Commission (1989-1990), Anchorage Literacy Project (1998-2006); and

WHEREAS, Mr. Peavyhouse always served with wisdom, common sense, a sense of humor and a sincere desire to make organizations and communities better.
