A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FIFTY THOUSAND DOLLARS (\$50,000) OF REVENUE FROM THE U.S. FISH AND WILDLIFE SERVICE PARTNERS FOR FISH AND WILDLIFE GRANT PROGRAM TO THE AREAWIDE GENERAL CIP FUND 401 TO THE PROJECT MANAGEMENT & ENGINEERING DEPARTMENT FOR STREAM BANK RESTORATION AND SPORT FISHING ACCESS IMPROVEMENTS AT SHIP CREEK.

WHEREAS, the Ship Creek sport fishery provides economic benefit and recreational opportunity for Anchorage residents and visitors; and

WHEREAS, preventing erosion, restoring stream banks, and improving public access is essential to ensuring safe recreation along the creek and maintaining pedestrian access facilities; and

WHEREAS, the Project Management & Engineering Department, the Alaska Department of Fish and Game, the U.S. Fish and Wildlife Service, the Anchorage Waterways Council and other local, state, and federal entities are working cooperatively to sustain recreational fishing and tourism related activities along Ship Creek; now therefore

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of Fifty Thousand Dollars (\$50,000) of revenue be appropriated from the U.S. Fish and Wildlife Service Partners for Fish and Wildlife grant program for stream bank restoration and sport fishing access improvements at Ship Creek, and be contributed to the Project Management & Engineering Department within the Areawide General CIP Fund 401.

Section 2. That this Resolution shall become effective immediately upon passage and approval by the Anchorage Assembly.

Subject: APPROPRIATION OF \$50,000 FROM THE U.S. FISH AND WILDLIFE SERVICE PARTNERS FOR FISH AND WILDLIFE GRANT PROGRAM TO THE PROJECT MANAGEMENT & ENGINEERING DEPARTMENT WITHIN THE AREAWIDE GENERAL CIP FUND 401, FOR STREAM BANK RESTORATION AND SPORT FISHING ACCESS IMPROVEMENTS AT SHIP CREEK.

The Administration requests Assembly approval for the appropriation of \$50,000 from the U.S. Fish and Wildlife Service Partners for Fish and Wildlife grant program for stream bank restoration and sport fishing access improvements at Ship Creek.

These funds are matched by a previously approved appropriation of \$188,700 (\$185,000 grant from the State of Alaska and a contribution of \$3,700 from the 2001 State Categorical Grant Fund, AR 2005-237, AM 651-2005) for similar work along Ship Creek. This appropriation of \$50,000 provides additional support for construction of stream bank restoration and fishing access improvements.
