A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SIX MILLION TWO HUNDRED THOUSAND DOLLARS (\$6,200,000) IN HOTEL/MOTEL BED TAX REVENUE AND FORTY THOUSAND DOLLARS (\$40,000) IN ASSOCIATED PENALTY/INTEREST TO THE CONVENTION CENTER ROOM TAX FUND (202) TO PAY DEBT SERVICE ON THE NEW CIVIC AND CONVENTION CENTER AND OTHER PAYMENTS REQUIRED BY THE USE AGREEMENT WITH CIVICVENTURES AND THE SERVICES AGREEMENTS WITH THE PROFESSIONAL AND MANAGEMENT ANCHORAGE CONVENTION AND VISITORS BUREAU.

That Six Million Two Hundred Thousand Dollars (\$6,200,000) in Hotel/Motel Bed Tax revenue and Forty Thousand Dollars (\$40,000) in associated Penalty/Interest revenue are hereby appropriated to the Convention Center Room Tax Fund (202) to provide for payment required under the Use Agreement with CIVICVentures and payments required by the Professional and Management Services Agreements with the Anchorage Convention and Visitors Bureau..

This resolution shall take effect immediately upon passage and approval Section 2. by the Anchorage Municipal Assembly.

Convention and Visitors Bureau

In April of 2005, municipal voters approved a new 4% Hotel/Motel Bed Tax to help pay for design, construction and operation of a new civic and convention center. On December 20, 2005, the Anchorage Assembly approved the essential terms and conditions of a Use Agreement with CIVICVentures, see AO 2005-190. One of the essential terms was to establish a Convention Center Room Tax Fund for deposit of the new four percent (4%) Hotel/Motel Bed Tax and associated Penalty/Interest collected pursuant to AMC 12.20.020C and Anchorage Charter 14.05. This new revenue is pledged to pay debt service with any excess going to the convention center operating reserve (Interfund Transfer) or to the Anchorage Convention and Visitors Bureau as required by the Professional Services and Management Agreements (Professional Services).

The attached resolution appropriates all anticipated revenue resulting from the new 4% Hotel/Motel Bed Tax and associated Penalty/Interest into the Convention Center Room Tax Fund as required by the Use Agreement.
