WHEREAS, the rain garden program is a pilot program designed to help reduce stormwater run-off, improve the health of local streams and lakes, and educate property owners about environmentally-friendly landscaping and watershed stewardship; and

WHEREAS, the rain garden program supports the Municipality of Anchorage's National Pollutant Discharge Elimination System (NPDES) permit program; and

WHEREAS, the U.S. Fish and Wildlife Service has granted the Municipality \$35,000 to cover half of the costs that private property owners would incur, up to \$750 each, for installation of rain gardens; and

WHEREAS, the Watershed Management Division will provide guidance to property owners who install rain gardens; and

WHEREAS, the necessary match is provided by the Watershed Management Division's NPDES general funding source; NOW THEREFORE,

THE ANCHORAGE ASSEMBLY RESOLVES:

SECTION 1. That a sum of THIRTY-FIVE THOUSAND DOLLARS (\$35,000) in grant monies from the U.S. Fish and Wildlife Service be appropriated to the Federal Grant Fund (241), Project Management & Engineering Department, to reimburse private property owners half of their expenses, up to \$750, for the installation of rain gardens.

SECTION 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Assembly.

The Municipality of Anchorage received a grant of \$35,000 from the U.S. Fish and Wildlife Service to reimburse private property owners within the Municipality for costs associated with installing rain gardens on their property. A copy of the executed grant agreement is attached to this Memorandum.

A rain garden is one type of "bioretention" system — a system of pond or trench area, soil, plants and mulch that retain and percolate water instead of letting it run off as stormwater. Rain gardens utilize landscaping techniques and native plant species to create areas that allow stormwater to slowly infiltrate into the soil.

Run-off from roofs, driveways and yards can contain harmful pollutants. Rain gardens reduce the amount of pollutants flowing directly into storm drains from impervious surfaces because they allow the run-off to filter through soil first, becoming naturally purified before entering the water table. Rain gardens also help reduce flooding and maintain the base flow in streams. Ultimately, rain gardens improve water quality for wildlife and recreational activities. A cross-section drawing of a typical rain garden is attached to this Memorandum as Exhibit A.



I. **AUTHORITY**

This agreement between the U.S. Department of Interior, Fish and Wildlife Service (hereinafter referred to as the "Service") and the Municipality of Anchorage (hereinafter referred to as "MOA") is entered into under the authority of the Fish and Wildlife Coordination Act (16 U.S.C. 661 et. seq.), the Fish and Wildlife Act of 1956 (16 U.S.C. 742a-j), and the Partnerships for Wildlife Act (16 U.S.C. 3741).

II. BACKGROUND

The Municipality of Anchorage (MOA) is located in the northern portion of Cook Inlet and is home to about 300,000 citizens. MOA is responsible for helping residents and businesses understand the complexity of water quality-related regulations and provide options and incentives for positive changes to traditional stormwater management strategies.

MOA would like to initiate a rain garden program to promote environmental stewardship in the community. Studies have shown that rain gardens can allow 30% more water to soak into the ground than a typical lawn. In an urban environment, forests, wetlands and habitat are replaced with impervious surfaces. Stormwater runoff increases with impervious surface area, and baseflows of nearby creeks suffer from reduced infiltration. Rain gardens increase the amount of water filtering into the ground, reducing pollutants, runoff and increasing baseflows, while

providing additional habitat for wildlife and native plant species. Installation of rain gardens is one phase of a larger initiative to improve public involvement and educational opportunities.

This pilot effort will:

- Encourage voluntary installation of rain gardens through a community incentive program
- Reduce effects of impervious area runoff on nearby creeks and wetlands
- Initiate a larger, more extensive program for lot-by-lot landscape changes
- Provide an outreach and education component for businesses and residents alike on natural resource stewardship and good stormwater management practices

In January and February 2006 the Coastal Program and Partners for Fish and Wildlife Program, respectfully, invited proposals via the **grants.gov** website for projects that would advance the Program's purpose to promote and implement voluntary habitat improvement projects on private lands for the benefit of Federal trust species. The Rain Gardens in Cold Regions proposal was one of the projects selected for funding.

III. PURPOSE AND OBJECTIVES

This Grant Agreement is being implemented in order to provide MOA with funding to create a pilot project for rain gardens. The main goals of the effort would be to:

- Develop standards and criteria for rain gardens, as well as a process within MOA for technical assistance (site visits and formal recommendations to land owners).
- Develop pilot projects to demonstrate the effectiveness of rain gardens.
- Establish a mini-grant program for landowners to install rain gardens on their lots.
- Develop community stewardship by public outreach in the form of presentations, informational packets, t-shirts, stickers and awards.

IV. RESPONSIBILITIES OF THE PARTIES

A. The Service shall:

- 1. Contribute \$35,000 to MOA to carry out the objectives of the project. Total project costs are shown in Attachment A.
- 2. Provide incremental advances to MOA based on immediate need and provided a detailed spending plan is developed and submitted to the Service for review and concurrence. Administer the transfer of funds to MOA and monitor successful project implementation.
- 3. Provide a single point of contact to the project. That person is Mary Price, Anchorage Fish and Wildlife Field Office, 605 West 4th Street, Room G-61, Anchorage, Alaska 99501-2231, phone 907/271-2788; FAX 907/271-2786; email: mary_price@fws.gov.

The Service will notify MOA in writing via formal modification to the agreement of any changes to the Service's project manager.

B. MOA shall:

- 1. Conduct activities as described below and in Section C.
- 2. Attempt to secure additional funding or third party contribution of materials and/or labor related to the project as needed.
- 3. Ensure any cost-sharing arrangements with other partners are in full support of this agreement.
- 4. Present a detailed spending plan to the Service. Submit billings to the Service in support of incremental advances of project-related charges. Send the Service Project Officer copies, in support of billings, of: receipts for project materials and supplies, employee Time and Attendance reports, and an itemized list of non-salary, in-kind services provided to support this project.
- 5. Provide the Service with updates of project progress, including draft and final reports. These may be mailed or emailed to the Service's project officer.
- 6. Ensure that the Service receives notification immediately if this project is delayed for any reason.
- 7. Coordinate with appropriate vendors to ensure that all needed services are obtained.
- 8. Coordinate and come to consensus with other entities such as the MOA Salmon Restoration Program, NRCS and Anchorage Waterways Council so that similar efforts are the same or complimentary, not redundant, and are built upon the same standards and criteria.
- 9 Invite Service Project Manager and Hydrologist to potential sites and discussions with landowners
- 10. Comply with the necessary progress, financial, and sub-contract reporting requirements identified in Sections X and XI.

C Project Work Task Objectives:

- 1 Create and construct at least three pilot projects for demonstrating the effectiveness of rain gardens.
- 2 Develop standards and design criteria for potential sites and rain gardens.
- 3. Establish a mini-grant program for working with landowners to install rain gardens and a reporting and tracking system to document locations, amount of impervious disconnected, and effectiveness for overall impact of the program.
- 4 Develop at least one brochure or pamphlet for public outreach

V. PERIOD OF PERFORMANCE

The overall period of performance of this agreement is a period beginning on the date of the last signature below, and ending December 31, 2007

VI. AWARD AMOUNT

The Service will contribute \$35,000 from Coastal and Partners for Fish and Wildlife funds for the period of performance identified above.

VII. PAYMENT PROVISIONS

- A Upon acceptance of the terms and conditions of this agreement, the recipient may submit requests for payment, either an invoice or a Standard Form 270, Request for Advance or Reimbursement, no more frequently than monthly In accordance with the Debt Collection Improvement Act of 1996, all Federal Payments made after January 1, 1999, must be made by Electronic Funds Transfer (EFT), unless a waiver is submitted and subsequently approved by the Service. If an approved waiver is not on file in the Service's computer system, the EFT banking information must be on record, or the invoice will be returned to the cooperator as payment cannot be made.
- B. The original and two copies of each invoice/payment request shall be submitted to the Service Project Officer identified below for review and recommendation for payment to be forwarded to the Service Administrative Officer for approval and submission for disbursement. In accordance with U.S. Treasury regulations, payments will be made within 30 calendar days after receipt and approval of a proper invoice.
- C. Should the recipient be unable to complete the provisions of this agreement, monies provided by the Service which prove to be cancelable obligations or unallowable in accordance with applicable Cost Principles for State, Local, and Tribal Governments; 2CFR 225 and also the advanced, but unexpended, portion of any funds shall be refunded.
- D This agreement is intended to support a particular project for a specific period of time. Any portion of funds not expended at the completion of the period of performance of this agreement shall be returned to the Service, along with any interest earned on that amount over and above \$100 per year.

The Service Administrative Officer (Contracting Officer) is the only person authorized to sign modifications on behalf of the Service.

XIII. SPECIAL PROVISIONS

- A. The results of any studies or investigations accomplished under this agreement may be published jointly by the parties or by either party separately. Appropriate credits to the United States Department of Interior, Fish and Wildlife Service, shall be included in any formally published article, provided that the Service does not otherwise deem it appropriate to issue a disclaimer. Authorship shall not imply any privileges of copyright or permit other restrictions on distribution.
- B. Any research data collected under this agreement shall be jointly owned by the parties to this agreement. Both parties shall have complete and unlimited access to all such data.
- C. News releases and other publicity issued by either party concerning this agreement and its activities are subject to approval before release by the Service's Regional Public Affairs Office. Any approved publicity shall give due credit to all parties to this agreement and it shall mention the amount of Federal funding provided.
- D. No member of, or delegate to, Congress or resident commissioner shall be admitted to any share or part of this agreement or to any benefit that may rise therefrom. This provision shall not be construed to extend to this agreement if made with a corporation for its general benefit.
- E Seat Belt Policies and Program: Recipients of grants/cooperative agreements and or sub-awards are encouraged to adopt and enforce on-the-job seat belt use policies and programs for their employees when operating company-owned, rented, or personally-owned vehicles. These measures include, but are not limited to, conducting education, awareness, and other appropriate programs for their employees about the importance of wearing seat belts and the consequences of not wearing them.

- XIV. Termination, if necessary, shall be conducted in accordance with 43 CFR 12.84

- (a) By the awarding agency with the consent of the grantee or subgrantee in which case the two parties shall agree upon the termination conditions, including the effective date and in the case of partial termination, the portion to be terminated, or
- (b) By the grantee or subgrantee upon written notification to the awarding agency, setting forth the reasons for such termination, the effective date, and in the case of partial termination, the portion to be terminated.
