The 25 grant partially funds one attorney position. 26 27 The Anchorage Police Department (APD) documented Anchorage's growing gang 28 problem. APD initiated a five-part program to aggressively prevent and crack down on 29 gang violence. Some of the 40 new police officers added to the force in the past three 30 years are focused on the problem of gangs and related crimes of guns and drugs. 31 However, there is a growing backlog in the Alaska Court System in processing the 32 cases. According to the District Attorney for the State of Alaska, there are more than 33 2,500 felony cases awaiting disposition in Anchorage, including many gang cases. 34 Delays in processing mean the release of gang members into the community on bail. 35 36 Former U.S. Attorney, now U.S. District Court Judge Timothy Burgess recently 37 proposed a partnership between the Municipality of Anchorage and the Office of the 38 U. S. Attorney to help combat this problem. At Burgess' invitation, the Municipality 39 proposes to assign the Program to the U.S. Attorney's office. The Program will be a 40 staff specially trained in prosecution under federal laws, focusing primarily on gang-41 related crimes. Gang members prosecuted under federal law typically are processed 42 more quickly, with more severe consequences, than under state law, removing gang 43 members from Anchorage streets. 44
