ACCEPTING 2006 STATE OF ALASKA LEGISLATIVE GRANTS IN THE AMOUNT
OF ONE MILLION, ONE HUNDRED FIFTY THOUSAND (\$1,150,000) PER SENATE
BILL 231.

WHEREAS, the State of Alaska has appropriated One Million One Hundred Fifty
Thousand Dollars (\$1,150,000) to the Municipality of Anchorage (the "Municipality") as
capital grants per AS 37.05.315 for Anchorage Water & Wastewater Utility (AWWU)
capital projects; and

WHEREAS, the Municipality, AWWU and the Assembly have reviewed the
grants offered by the State of Alaska; and

WHEREAS, a duly advertised public hearing was held in accordance with
Section 6.10.085 of the Municipal Code;

NOW THEREFORE, the Assembly of Anchorage resolves:

Section 1. State Legislative grant funds in the amount of One Million One
Hundred Fifty Thousand Dollars (\$1,150,000) are hereby accepted as follows.

Section 2. That the Mayor of Anchorage acknowledges the grant offer and

Assembly.
