A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY TO PROVIDE FOR AN INDEPENDENT AUDIT OF DEPLOYMENT AND RESOURCE ALLOCATION WITHIN THE ANCHORAGE POLICE DEPARTMENT TO BE FUNDED BY APPROPRIATION OF MONIES FROM THE 2006 AREAWIDE FUND (101) BALANCE.

WHEREAS, in addition to audits approved in the 2006 Audit Plan, Anchorage Municipal Code authorizes audits to be undertaken at the direction of the municipal assembly; and

WHEREAS, resource allocation, deployment of patrol officers to meet calls for service, and the balance of sworn staff and civilian personnel to handle investigative or administrative duties are critical components in meeting the law enforcement challenges now facing our community; and

WHEREAS, Anchorage may experience periodic shifts in the location and demand for law enforcement resources, based on many factors such as seasonal changes in weather and daylight, population growth and shifts among and within Assembly districts, communities and neighborhoods; and

WHEREAS, specialized audit and technical expertise is required for meaningful independent review and audit of deployment and resource allocation within the Anchorage Police Department; and

WHEREAS, patrol staffing and deployment was last independently reviewed in 1996 by the International Association of Chiefs of Police (IACP) as part of a larger performance audit of the Anchorage Police Department; and

WHEREAS, when reviewing the current law enforcement needs of our community, it is important to the Assembly to understand and consider factors such as patterns in the origin and time of day of calls for police services, the balance of duties between emergency and non-emergency responses, community policing and conduct prevention, traffic and special missions, investigations, training, and administrative duties; and

WHEREAS, it is appropriate to obtain independent review and audit services by Request for Proposal (RFP); and

- The independent review and audit shall be obtained through purchasing 2. department solicitation, by a Request for Proposals for a professional services contract, setting out the scope of work consistent with this resolution, the time for completion, and other requirements deemed appropriate by the audit proposal review committee.
- The Chair of the Assembly shall serve on the audit proposal review 3. committee as the initiating entity representative. In addition to the appointment of a representative from the Controller Division and the Internal Auditor, the audit proposal review committee will include at the request of the Assembly, the audit committee chair or designee, the public safety committee chair or designee, the Chief of Police or designee, and a member of the public not employed by the municipality.
- Selection and award will be presented to the Assembly for appropriation of funds, not to exceed \$75,000.
- After selection and award, members of the audit proposal review committee will provide direction and assistance as needed during the audit to ensure that information is made available to allow the work to be accomplished timely.
- The successful bidder shall complete the scope of work for presentation of a written report for Assembly review.
