The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$128,146.32 for a DUI .08 Impaired Driving and Seat Belt Enforcement program. This grant was intended to support focused enforcement during the period April 1, 2006 thru September 30, 2006. To maintain compliance with conditions of this grant, the department would violate terms of the APD Collective Bargaining Agreement. The department has already accepted the amount of \$30,300 of the total grant award for enforcement performed during the period May 1, 2006 thru May 31, 2006. In an effort to provide focused impaired driving enforcement over the Labor Day holiday, the State of Alaska has relaxed its grant conditions and has approved an additional amount of \$14,470 for this enforcement project.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$270, which has been budgeted in the 2006 Police Operating Budget. This program grant is being presented for appropriation after the start of the actual performance period due to negotiations to determine grant acceptance/rejection. This grant began on April 1, 2006 and will end on September 30, 2006.
