The Municipality of Anchorage has received a grant from the Alaska Mental Health Trust Authority for a Crisis Intervention Team Training Conference Program. This training conference has won best practice awards from the U.S. Department of Justice, the White House, and Amnesty International and is offered annually, to law enforcement agencies throughout the nation.

This grant funding will be used to reimburse conference fees, airfare, lodging, and per diem costs for six sworn officers of the Anchorage Police Department to attend the 2006 Crisis Intervention Team Training Conference. Through increased law enforcement awareness of issues associated with mental illness, citizens residing in the Municipality of Anchorage will experience a safer living environment.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$190, which has been budgeted in the 2006 Police Operating Budget.
