8 THE ANCHORAGE ASSEMBLY RESOLVES:



Subject: Appropriation of Accrued Interest from the U.S. Department of Justice, Office of Justice Programs, Local Law Enforcement Block Grant (\$4,200)

In July of 2004 the U.S. Department of Justice, Office of Justice Programs, awarded the Municipality of Anchorage, Anchorage Police Department, a Local Law Enforcement Block Grant in the amount of \$128,175. With the required Municipal match of \$21,862, the total grant program was \$150,037. This grant was used to fund enhancements for various communications and computer systems related to records management technology.

One of the conditions of this grant was that all federal funding be placed in an interest bearing account and the accrued interest must be used for police programs and activities. This grant expires on September 30, 2006, the accrued interest of \$4,099 and estimated interest of \$101 must be appropriated.

The Anchorage Police Department will apply appropriated monies for the purchase of additional equipment for the records management and technology services division, approved grant budgetary expenditure areas.
