**A RESOLUTION IN SUPPORT OF THE DEPARTMENT OF NEIGHBORHOODS TO
SUBMIT TO THE STATE OF ALASKA AN APPLICATION FOR A FEDERAL GRANT FOR
HISTORIC SURVEYS OF ANCHORAGE'S NEIGHBORHOODS**

WHEREAS, pursuant to the National Park Service Historic Preservation Act of 1966, certain federal share matching grants for historic preservation projects are available to certified local governments; and,

WHEREAS, the Municipality has begun the process of analyzing Anchorage neighborhoods for historic potential to assist with the environmental review process for housing programs; and,

WHEREAS, an historic survey of Mountain View housing stock was completed in 2005, an award for an historic survey of Fairview was made in 2006 and an historic survey of Government Hill was completed as part of an unrelated process; and,

WHEREAS, the 2006 and 2007 Housing and Community Development Action Plan designate Community Development Block Grant (CDBG) funds under the MOA Minor Repair Program/Historic Surveys activity to serve as match to past and any future grant awards from the State Historic Preservation Office; and

WHEREAS, the current 2007 Housing and Community Development Action Plan proposes to fund an historic survey of the Spenard neighborhood, pending successful ~~award of~~ award of funds from the State Historic Preservation Office; and


WHEREAS, the Department of Neighborhoods is established as the agent for the Municipality of Anchorage for administration of this project,
