Security Law Enforcement Terrorism Prevention Program Grant (\$993,576)

The Municipality of Anchorage, Anchorage Police Department has received from the Office for Domestic Preparedness through the State of Alaska, a grant to enhance security and preparedness for terrorist prevention. Appropriation of grant and required local matching funds is requested to the State Categorical Grants Fund (231).

Grant funds awarded provide for the procurement of specialized terrorism response equipment, interoperable radio system repeaters and supply items to be utilized by the Anchorage Police Department.

FY2006 Law Enforcement Terrorism Prevention Program Grant funds will be administered by the Anchorage Police Department. A special condition of this grant is that the department contribute funds to support associated indirect grant costs.
