Department of Justice, of a Bullet Proof Vest Partnership Program Grant. (\$8,890)

On October 25, 2004 Public Law 108-372 reauthorized the Bulletproof Vest Partnership Grant Act of 2000 and extended the program through 2007. The program provides for up to 50% reimbursement of department costs for the purchase of replacement ballistic armor for its sworn officer force. This grant provides funding for jurisdictions with a population of under 100,000 first and then proportionately divides any remaining funding to other applying jurisdictions. This grant program year provided 10.56% of the total request of jurisdictions with a population of over 100,000.

The Municipality of Anchorage, Anchorage Police Department, has received a grant from the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice to offset the costs of supplying bullet proof vests to sworn patrol officers in the amount of \$8,740.

A special requirement of this grant is that the department provide a contribution to cover unallowable indirect intergovernmental charges. The total anticipated department cost is \$150. This grant began June 1, 2006 and will end on September 30, 2008.
