6 WHEREAS, the Watershed Management Division develops analytical and evaluation
7 strategy and conducts sampling to the satisfaction of the Alaska Department of Environmental
8 Conservation (ADEC) for identification of sediment sources in Little Campbell Creek; and

10 WHEREAS, this function supports the Municipality of Anchorage's National Pollutant
11 Discharge Elimination System permit program; and

13 WHEREAS, the ADEC has granted the Municipality \$32,000 to conduct a project to
14 identify Best Management Practices that reduce sediments and adsorbed pollutants in Little
15 Campbell Creek; and

17 WHEREAS, the necessary match is provided by the Watershed Management Division's
18 NPDES general funding source; now therefore,

20 THE ANCHORAGE ASSEMBLY RESOLVES:


22 SECTION 1. That a sum of THIRTY-TWO THOUSAND DOLLARS
23 (\$32,000) in grant monies from the Alaska Department of Environmental Conservation be
24 appropriated to the State Categorical Grant Fund (231), Project Management & Engineering
25 Department, to identify sediment sources in Little Campbell Creek.

SUBJECT: A Resolution Appropriating an Alaska Department of Environmental Conservation (ADEC) Grant to the State Categorical Grant Fund (231), Project Management & Engineering Department, to identify sediment sources in Little Campbell Creek (\$32,000)

The Municipality of Anchorage received a grant in the amount of \$32,000 from the ADEC to conduct a water quality monitoring project in order to identify sediment sources in Little Campbell Creek. Measurements of total suspended solids, turbidity, sediment characterization, stream channel transects, adsorbed pollutants and stream discharge will be taken over the one-year project period, starting September 2006 and ending August 2007. The Watershed Management Division will be responsible for all reporting requirements to the ADEC.

Project tasks include reviewing existing sediment loading data; establishing a technical advisory committee to discuss methodology and sampling plan; developing a quality assurance project plan; developing a monitoring and sampling plan; conducting sampling; contracting out laboratory analyses; purchasing monitoring supplies and equipment; and data entry, analysis and evaluation. Results will be reported to the ADEC, recommending Best Management Practices to improve water quality in Little Campbell Creek.

The required match of \$21,500 and \$650 for central services will come from the National Pollutant Discharge Elimination System funding of the Watershed Management Program. The accounting detail is as follows:
