8 **THE ANCHORAGE ASSEMBLY RESOLVES:**



3 Subject: Appropriating \$10,000 as a donation from ConocoPhillips to the Miscellaneous
4 Operational Grants Fund (261) for the Westchester Lagoon Family Skate

6 For the sixth year, ConocoPhillips has joined Anchorage Parks & Recreation as a corporate
7 partner for the Westchester Lagoon Family Skate. Since 1995, Westchester Lagoon has been
8 transformed into a Norman Rockwell scene of frolicking skaters with the fun, family atmosphere
9 attracting hundreds of people each Saturday. We have radio stations with DJ's to provide
10 music and fun. There are burn barrels to warm up and nearly one mile of groomed ice skating
11 trails that add to the setting. Westchester Lagoon has become a showcase of the benefits of
12 family recreation and corporate sponsorship. This donation of \$10,000 from ConocoPhillips is
13 greatly appreciated and will be used for radio participation, advertising and support of the
14 Citizens Silver & Gold Skate Event. Expenditures are approved from December 2006 to April
15 2007.
